Agreement to pay fees and Waiver of Liability

I understand and agree to abide by the following:

Tuition is payable monthly by the 1st of each month. A late fee of \$25.00 will be applied to all accounts not paid by the 7th of each month. *Turning Pointe Dance Theatre* accepts cash or check. Payments may be mailed but must be postmarked by the 1st of the month to avoid a \$25.00 late fee. If payment has not been received by the end of the month, student will not be able to continue in class until payment has been received. The studio year begins in August and ends in June. The Registration Fee is for one year including summer classes. You will be required to reregister and pay a new registration fee each dance year. Occasionally there are 5 weeks in a month and *Turning Pointe Dance Theatre* reserves the right to designate any 5th week in a calendar month as regular class time to offset established Holidays (Thanksgiving, Christmas, Spring Break, etc.). December is a full month of tuition, no exceptions to this rule. If your child misses due to illness or family vacation, full tuition is still required. If there is a long break in attendance or failure to pay tuition, the class reservation will be forfeited and a new registration fee will be required to rejoin the class. There are **NO PRORATED MONTHS** during the year and there are **NO REFUNDS**. \$35.00 cash, plus cash replacement will be expected for all returned checks.
